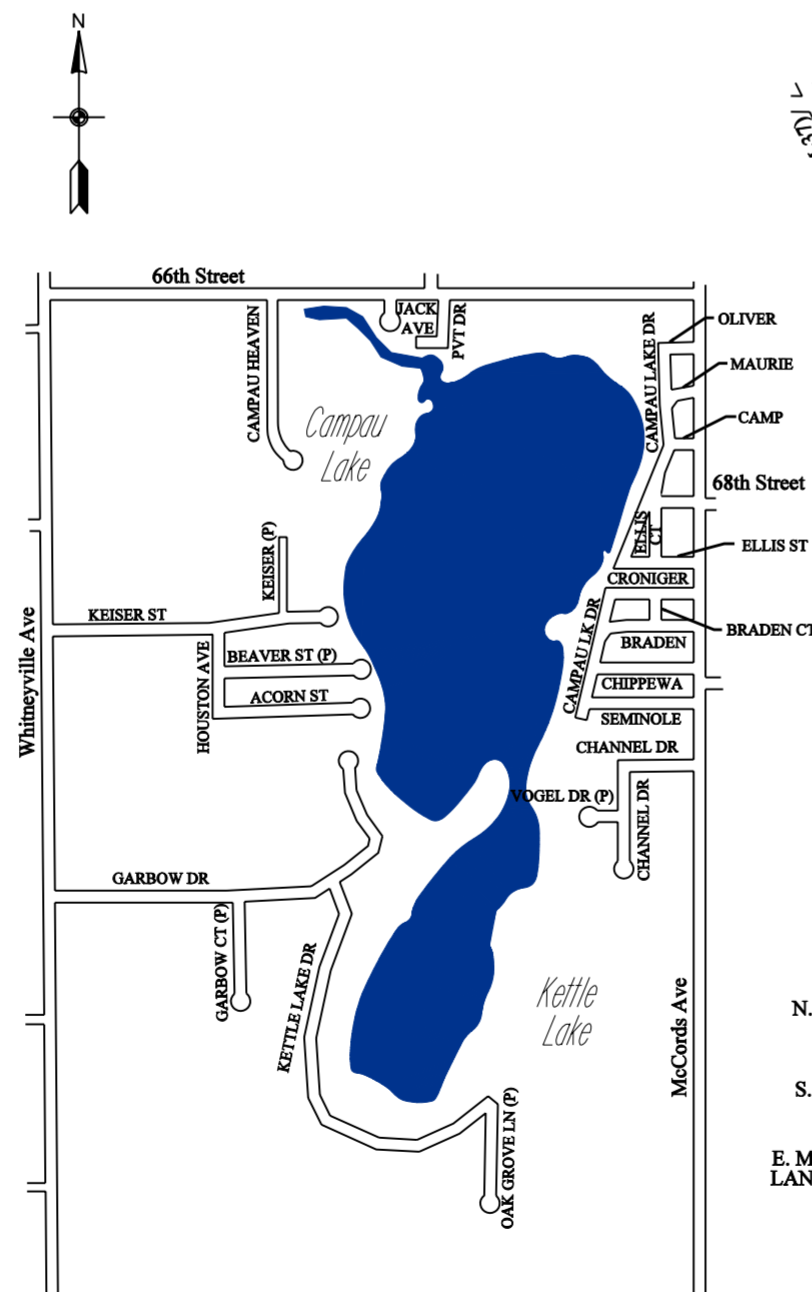
LEOPARD PARK, CHERRY VALLEY WOODS,

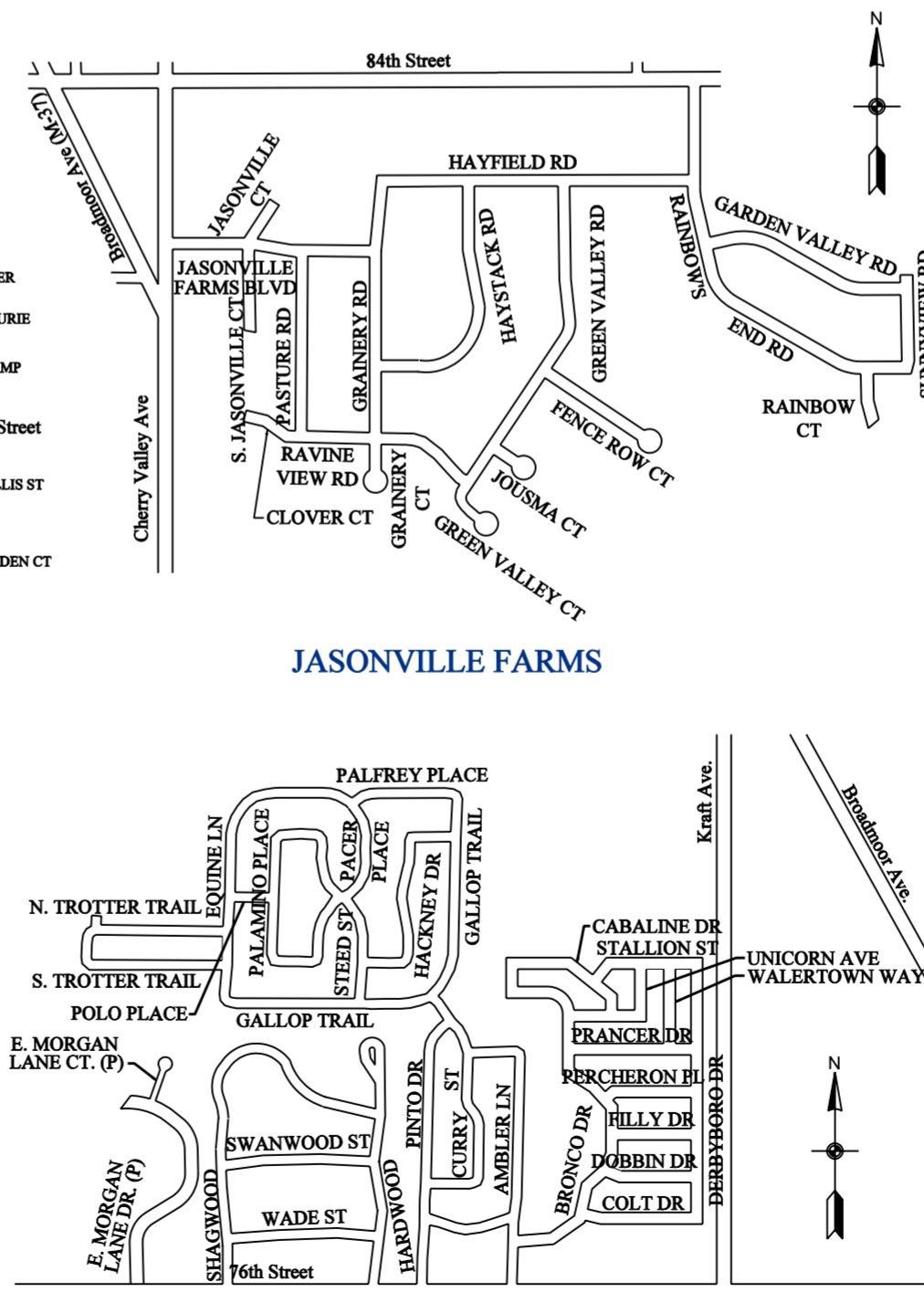
